Such release of liability includes, but is not limited to liability for any sickness, disease, theft, death or injury (fatal or not fatal) to or incurred by me, any horses, or any property while at the grounds. Any and all claims are hereby waived and released and I covenant not to sue thereafter. I know that horseback riding is a potentially hazardous activity. I should not ride unless I am medically able. I agree to abide by the decisions of my instructor and stable officials relative to my ability to safely ride.
